Schedule Expectations

Students need to plan to be available for placement during business hours maintained by the agency and during times when the professional staff are working and available to the student. If you work, you must have a flexible employment schedule in order to accommodate your internship schedule.

Students cannot expect to complete all of their field hours during evening or weekend hours. Students are expected to engage in their internship for 16 hours per week. Internship sites offering student placements solely during the evening or weekend hours are rare and sometimes nonexistent. Therefore, the School of Social Work is under no obligation to provide such placements.

Students must be prepared to attend their internship in person. We are not able to commit to or guarantee being able to identify a fully remote internship for any student. Most agency staff work on-site, though most agencies and internships now have some hybrid opportunities which provide a bit more flexibility in scheduling for students. While there may be limited availability of fully remote placements, the School has a responsibility to be aware of and responsive to the context of the practice communities with whom we partner and what they can support structurally.

CRIMINAL RECORD

The School of Social Work makes no presumptive judgments regarding the conviction history of a student and potential field placements. This policy is intended to ensure that the School of Social Work field team will make a reasonable effort to identify a suitable field agency that will provide a placement for a student with a conviction history. Students need to know that in fulfilling this effort, certain types and calendar dates of criminal convictions may result in some agencies declining to offer them a field placement. In some instances, it may not be possible for the field team to find a placement willing to interview or accept the student. In such a case it is likely that the student will be unable to complete the BSW or MSW program. If placement is not possible, the student may be referred for a Performance Review (see BSW or MSW Program Handbook).

Students are required to notify the Director of Field Education about any arrest, conviction, or pending charge that occurs subsequent to their most recent field application and/or background check.

DISABILITIES

BACKGROUND CHECKS, IMMUNIZATIONS, SCREENINGS, AND TRAININGS

Background checks are now required by most agencies that serve as field placement sites for social work students. A student who wishes to be placed in an agency that requires a background check or other screenings or trainings will need to complete those as a condition of being placed. Some agencies prefer that students use the agency's vendor and procedures while other agencies expect students to use the School's procedure.

Additionally, students living in Oregon and interning in settings including, but not limited to, ambulatory care settings, clinics, hospitals, hospice, residential care facilities, long term or skilled nursing facilities are required by law (OAR 409-030-0100 to 409-030-0250) to comply with, and provide documentation of to the School, specific immunizations, screenings and trainings. Please note that some placements require students to complete pre-placement screening and training including passing a 10-panel drug screen, which includes screening for marijuana/cannabinoids; CBD products may contain cannabinoids which can impact a drug screen. Federal regulations do NOT recognize legalized or medical marijuana in any state. Failure to pass a drug screen due to a positive screen for marijuana/cannabinoids will result in disqualification for certain internships.

The School of Social Work has contracted with Castlebranch to provide School-Funded background checks, HIPAA and OSHA trainings, 10-panel drug screening, and the Medical Document Manager on behalf of agencies providing field placements for our students. If an agency will accept screenings and trainings from Castlebranch, the Field Education Program will notify the student and provide detailed information about how to order the School-funded packages. Students may be required to pay for the cost of immunizations, screenings, or trainings.
