





Sample of TA Requests

Type & Topics



Consultation

- Instructional design/vignettes
- Domestic/intimate partner violence
- Recruiting and retaining practicum placements
- Establishing an interprofessional education/degree program in an academic setting
- Securing buy-in from physician colleagues in integrated care settings



Trainings

- Trauma-informed approaches to assessing, preventing and treating transitional-aged youth who experience dating/intimate partner violence
- Integration of behavioral health services in pediatric primary care settings
- Compassion fatigue, burn-out and traumatic stress for behavioral health staff
